

RESOLUTION UPON THE DEATH
OF
T. DEAN LOWER, ESQUIRE

WHEREAS, The Almighty has called to His eternal reward one of our brothers, Mr. T. Dean Lower, an attorney, who died on September 9, 2009; and

WHEREAS, the Blair County Bar Association Board of Governors has called an assembly of the Blair County Bench and Bar in profound sorrow to make this memorial tribute to a fellow attorney; and

WHEREAS, the Committee designated by Mary Lou Maierhofer, President of the Blair County Bar Association, respectfully submits the following Resolution upon the passing of T. Dean Lower, whose death brought profound sorrow to all of those who knew him.

T. Dean Lower was born September 27, 1917 in Williamsburg, Pennsylvania, a son of Thaddeus and Anna Lower. Dean was a 1935 graduate of Williamsburg High School. He graduated from Dickinson College, then concluded his formal education upon the receipt of a law degree from Yale Law School in 1947. He was a member of Phi Beta Kappa fraternity. He was admitted to the Pennsylvania Bar in July 1949, and practiced uninterrupted for 53 years until his retirement on January 31, 2002.

He was twice married; first to Jane Young on March 23, 1942, who preceded him in death March 30, 1987, and then to Jane Patterson Kazmaier on June 2, 1988, who preceded him in death May 16, 2008.

Dean was a veteran of World War II, having served in the U.S. Army Air Corps.

He was instrumental in the development of the Lower Trail and Lower Lookout at Chimney Rocks Park, Hollidaysburg. These were named in his memory. He was the first recipient of the Philanthropic Award given by the Central Pennsylvania Community Foundation.

Dean is survived by a daughter, Janna Lower and husband Mark Tanner, and a stepson, John Kazmaier and wife, Deedra, and a sister, Grace Hamil. He was preceded in death by a son, Roger Dean and a brother, Ralph. T. Dean Lower, Esquire will be missed by all who knew and loved him.

We cannot understand the brevity of life's span and words are wholly inadequate to express our deep sense of loss at his passing.
